

**The "I Care" Scholarship
Kinsley High School
Established 1984**

Designed for the KHS graduating senior:

Who plans to enroll in post-secondary training (community college, four-year college, or vocational- technical school); who has a 3.2 or higher GPA cumulative at the high school level; whose character continues to demonstrate a "caring" concern for self and for other individuals; whose high school record indicates "sound" attendance patterns whose involvement in the high school and the community program has consistently been dependable, reliable, wholesome, and supportive

Prospective applicants are to:

Three parts: (1) Complete the cover application form and submit a current transcript to the chairperson of the committee; (2) Submit a 500-word essay (minimum) in typed form explaining the importance of caring in the individual's life - what makes the spirit important, how the individual not only now but also hope to make the spirit of caring evident; (3) Submit two letters of character reference, one coming from a community source (non-family) and one from a member of the current high school staff.

The omission of any part of the above forfeits the application of the candidate.

Value of the scholarship:

\$500 with \$250 payable upon proof of enrollment for the fall semester classes; \$250 payable upon proof of enrollment for the spring semester classes providing that the student has secured at least a 3.2 GPA for the first semester's program. Funds are handled by Mrs. Kim VanNahmen, 414 South Main, Offerle, Kansas 67563 under the auspices of the Offerle National Bank, Offerle, Kansas 67563. The scholarship may be renewable upon request to the chairman of the funds.

Selection process:

Mrs. Kim VanNahmen, Offerle, Kansas 67563 will coordinate the selection process, likely using a two- member community committee to evaluate the applicants and to determine the recipient. The committee has the right to collect any information from the school and/or the community concerning a candidate in helping to select the recipient. The decision concerning the recipient rests with the committee, not with the donor of the funds. The committee also reserves the right to withhold funds for a given year.

Benefactor:

The anonymous donor determines the amount of funds allotted for scholarship purposes on a yearly basis.

Due Date:

Applications and letters as well as support materials are due by April 1 of any given year. The announce of the recipient is to be made by May 1 of any given year. All inquiries should be directed to Mrs. Kim VanNahmen, 414 South Main, Offerle, Kansas 67563.
