To op st m ec sp	per the student handbook adopted by the Board of Education: o allow students greater flexibility, the Kinsley-Offerle School district USD #347 will offer senior students the oportunity to pursue a wider variety of options during the last semester of their senior year. This will allow tudents to enroll in college classes previously unavailable to them due to scheduling constraints associated with teshing the college and KJSHS schedules or students could be released to work, earning more money for future ducation experiences or endeavors. Students who chose this option may not be eligible for athletics or activities consored by the KSHSAA since they require a student to be enrolled in a minimum of five classes for articipation in extra-curricular activities.
T	he following guidelines for participation in the early release program are as follows:

All students who desire to participate in the senior early release program must have their applications opproved by the counselor, principal, and parent. The principal will have the final say in the level of articipation that the student may be involved in. Applications must be completed and returned to the guidance office during the fall semester of the student's enior year by November 15. Student must also be current on all financial obligations. Courses taken at KJSHS during the second semester must be consecutive hours. Students may not enroll in Work Study (Internship) and participate in this program during second semester. There would be no need for this concurrent enrollment.) Student may still participate in normal school functions if eligible such as prom, senior trip, and graduation eremonies. Student may not hang around school if participating without principal's approval. For example: Student may be enrolled in 1st and 2nd hour and then their early release starts. 3nd hour through 7th hour, the student will eved to leave the premises and only enter through the KJSHS office much like a visitor to the building would. Students participating in the early release program will, whenever possible, schedule appointments during the ortion of the day in which they are not required to be in attendance.
